DISTRICT DIRECTOR'S REPORT

Reflecting on my year as ACBL President, it has been quite a good year. The major challenge was to find a new CEO to replace Jay Baum who chose to retire as of June 30, 2012. Jay and I made an agreement that if we could get someone to start earlier that he would step down and act as a consultant until his retirement date and also that if it took longer he would stay on until at least the end of 2012.

First step was to choose a search committee which turned out to be a committee of eight including myself and fellow board members Sharon Anderson, Egan MN; Bruce Blakely (chair), San Rafael CA; Joan Gerard, White Plains NY; Dan Morse, Houston TX; and Rand Pinsky, Valencia CA. We then added two bridge playing CEOs, Steve Beatty, Mill Creek WA and Bob Blanchard, Scarsdale NY.

We set up a couple of rules. The CEO must be a bridge player, have high level managerial experience and must be willing to work at headquarters in Horn Lake, MS. We advertised in many bridge publications and on the internet bridge sites. And then we waited and wondered what we would get. Finally someone applied. He was a CEO, had a great work record, and lived in the Memphis area. We thought it was a made up resume, it looked so good. We searched the internet and within 24 hours we had more information on him than we would ever need. It is scary what all is out there about people.

It is now February and more resumes came trickling in. We set up a rating system and all eight of us rated the individuals. We would later use the ratings to determine who we would interview via a conference call (which usually lasted about two hours). But the Spring NABC in Louisville was about to start, so I would be running my first Board meeting. The meeting was fairly uneventful and the tournament was great. The city of Louisville was lovely and the tournament was very well run. The Volunteer Dinner was at Churchill Downs and was the best venue of any dinner to thank the volunteers who make the NABCs run smoothly that we had ever had.

Well the resumes kept a coming and the interviews began.

Most of the interviews were good, we had found some possible candidates (our dream candidate eliminated himself by wanting more money than we could afford). We made a decision to spend a weekend in Las Vegas and interview the finalists. This was an effort to save money because we, too, had a budget. I am not sure anyone ever counted the applicants, but we received about 85 resumes, interviewed about 35 by phone (we broke into two four-person teams), and interviewed 12 in Las Vegas over two 12 hour days.

This was working very well, and some felt we might be able to have a candidate to present to the Board for approval in Toronto although Seattle still seemed a more reasonable target. We had to get references and do background checks and assure ourselves that we had the right man (yes, we had one fe-

male candidate, but at the eleventh hour she backed out and decided not to come to Las Vegas).

Exit Craig, I was about to embark on a 36 day tour of clubs East of the Mississippi. I had already been to New England for five days and visited six clubs there. I went to MIT which was originally scheduled at the end of the 36 day trip but I moved it into April so the visit would be when school was in session. MIT had eight tables but only one student played although most of the players were former students. The tour was great, the players were very appreciative that the President of the ACBL was visiting their club. However, I was there not to be appreciated but to say thank you to the clubs for recruiting 12,000 new members every year.

I was able to stay in touch with the Search Committee during this trip. From the beginning the committee felt Robert Hartman was the man! But we had our reference checks and background checks and we also gave candidates the opportunity to visit Horn Lake on their own if they wanted. Sure enough one candidate withdrew. We offered Robert Hartman to come to Toronto for Board approval.

Now as President, I also got to negotiate both an amendment to Jay's contract and negotiate a contract with Robert. I managed to get those contracts done before Toronto. Clearly having Robert meet the Board was the most important happening in Toronto. The Board unanimously approved him. A gentleman named Nicholas Hammond was also in Toronto and met with some members of the Board there. He will become an important person in this year also. I left Toronto and stopped at the Liverpool regional on the way home.


A week at home, and then I was off to a 44 day adventure to the West. This started with a flight to Fargo, ND. I had never been to Fargo, I had a great time there. Elaine would join me in Kansas City and then leave from Dallas to go home for the Valley Forge Regional (and an earthquake and a hurricane). Meanwhile the tour was going great and I was able to contribute some to the selection of Nicholas Hammond as the project manager of the ACBLscore rewrite. This would be the third major part of my year although most of the programming if we proceed will be done in 2012.

Texas is a great bridge state. I visited seven cities and saw seven great bridge clubs. It was hot, however, with the average high temperature reaching 107 degrees which was nothing compared to the 33rd time this year it hit 110 degrees in Scottsdale. Elaine retuned in Los Angeles and we proceeded up the coast to Vancouver, BC and then swung over to Sand Point, ID for the 99th club. I have been basking in failure ever since wondering where I would go for #100.

Home for three weeks before going to the Netherlands for the World Championships. I represented the ACBL at their meetings. The six USA teams all qualified out of the 22 team events (Bermuda Bowl, Venice Cup (Women) and D'Orsi Cup (Senior) into the quarterfinals. The Netherlands was fun but I was glad to be home even if only for a week before going to Lancaster.

It has been a great year, I am now on my way to Seattle for the Fall NABC. Happy Holidays to everyone. I am not sure but I believe I will have been on the road for about 210 days this year. I am looking forward to spending 2012 in District 4.

DISTRICT 4 MASTER SOLVERS CLUB

HENRY BETHE, DIRECTOR

A sparse set of responses. Probably my fault because I did not send the problems out but relied on both panelists and solvers to read the column and respond. Didn't work. But because of that all responses are included in full.

Problem 1.

In the golden olden days we were counseled not to open weak twos with a void because that made partner's evaluation harder. Obviously that has gone the way of all flesh. At the WC virtually everybody would have opened either 1H or 2H. 3H with the moth eaten suit and pass would have attracted little support.

Shuster: 3H. The modern trend is to open this hand type with a one-bid, but I still prefer to have more in the way of defense when I hold sub-minimum high card strength. For me, the issue is between 2H and 3H. The suit texture argues for the weak two, but the extra shape and playing strength convince me to make the bigger bid.

Raskin: 2H If the opponents have S this might make it more difficult for them to compete or easier for us to evaluate our combined assets. It does look like you want to get partner off to a H lead if you are on defense.

Foster: 2H I don't like it, mostly because of the void, but all other possible bids or pass seem worse. Marty Bergen advises something like "if it looks like a weak two bid in a major, bid a weak two in the major, regardess." If my partner complains later, I might claim that I mistook one of my baby clubs for a spade.

Praha: 2H. When partner bids 2NT, I can bid 3S (good hand, good suit) playing Ogust, and 3C playing feature. This hand is not good enough to bid 3C, and passing gives opponents a free run.

B. Cohen: 2H - seems pretty close to an ideal vul weak two bid: I've got

good hearts and I'm at the high end of the range (with a different vulnerability and seat, I would consider 3H with this hand).

Wachsman: 2H. While I avoid opening weak 2's with a void, this hand warrants an exception. It may be the only chance to suggest a heart lead while presenting a potentially viable strain with which to compete.

Filandro: 2H, if we have agreed on Ogust. I am well-placed to respond good suit, good hand if partner bids 2NT. *Note that Filandro offered a second answer (below) if we agreed to play "features" over a 2NT inquiry. This is a fairly strict definition of a feature, namely a side Ace or King. I believe that QJxx is a fine feature.*

Straguzzi: 2H. Seems like a normal hand for a vulnerable weak two. Not quite enough in honor tricks to open 1H, no reason to distort with 3H (particularly in second seat), and the spade void isn't nearly enough of a flaw to pass.

Glassons: 2H. We play that our opening 2H bid in second seat is sound since partner hasn't had a chance to peep and is likely marked with values. 2H has the added advantage of taking away one level of bidding since lefty is likely to be long in spades.

HARRIS: 2H. In real life, this is the bid. I am not passing or psyching spades. I have a good suit and am showing a value bid. 3H is not right vulnerable with a 6 losing trick count.

K. Cohen: 1H. Even though I only have 9 points, I have a potentially a very good trick taking hand. If you open this hand 2H you may easily go plus 170 for minus 10 IMPS. Hands that have voids are just so much more powerful than most give credit for. If you change your Spade holding to a stiff King, most would open because you have 12 points, but that is a much worse playing hand. If you treat a void like an Ace, you will do so much better in bidding most suit contracts correctly.

Schwartz: 1H. What's the problem?

Teukolskys: 1H. Too much danger of missing a game if you pass a hand with this playing strength. If partner drives to game because of his KQJx of spades, that's too bad. But we only need about 8 useful points outside of spades for game to be on a finesse.

Filandro. Pass, if we have agreed on "feature"- or if we are "undiscussed" due to our lack of time for pre-game discussion. I am not quite worth an opening one-bid, but I would hate to open 2H and have to show "no feature" with such a promising hand.

Shuste: 2S. I just need the heart ace and two trumps to give us a play for 4S, so passing is too committal. If partner persists with 3H, I will give up there.

Foster: 3C. This is a very risky bid trying to find 3 NT. If partner rebids 3 hearts I will pass.

Praha: P. NV at imps, I see no reason to bid further on what is a potential misfit where we rate to lose at least 1 spade, 1 heart and 2 clubs.

Raskin: 2S. Looks like the hand is too strong to not make a try for game. It might be right to bid 2NT and get a better idea of the combined assets, but that might shut us out of the S suit and my S holding is good enough to play opposite xx.

B. Cohen: 2S - seems like a good start - I'll be well positioned to bid 3D over likely 3C competition.

Wachsman: 3C. It is important to show a very strong hand while giving partner a chance to bid 3nt with club stoppers.

K. Cohen: P. Remember partner is Non Vul. You also only have 1 trump. What is a typical hand Partner is likely to have? xx KQJxxx xx xxx. With this hand Partner may or may not make 2 Hearts. There is no reason to raise the contract, or look for some type of game. This may be your last chance to get a plus score.

Schwartz: P. Don't like any of the other calls. I run the risk that partner has 3 spades to the king and the ace of hearts. But partner never has the right cards when I bid, only when I pass!

Filandro. 2S. A comfortable choice.

Teukolskys: 2S. Every now and again partner will hold 3 spades and a useful heart suit, so we have to make a try. Probably would pass in

matchpoints.

Glassons: 2S. Our hand is too good to not think that we have game prospects in one of our suits. Over partner's likely 3 H rebid, we will bid 4 D.

Straguzzi: 2S. The auction hasn't gone very well so far, has it? I believe that 2S is constructive and non-forcing in BWS, and that's all this once-promising hand is worth at the moment. If partner passes, even a 5-1 fit should play okay with my strong trump suit, possibly even better than a 6-1 fit in hearts. Both a cue-bid and a pass are too extreme, though it wouldn't shock me if one or the other was the winning call.

HARRIS: Pass. No reason to bid with 3 1/2 tricks. It can only lead to trouble. The only reasonable contract for EW is 3C or 3NT which will be doubled for a non-heart lead or the AH (if held) at 3CX.

On the actual hand partner had x/AJ9xxx/xxxxx/x. The board was played at eight tables. At seven of them the auction started this way. At the eighth this hand overcalled 3H. Heart contracts took 9 tricks, losing three hearts and a club. At three of the eight tables our problem hand chose to bid 2S and heard partner bid 3D. All of these scored 420 in 5D.

Shuster: No. Redouble is on my short list of worst bids ever made for me in bidding contest (well behind a couple of psyches!)

Straguzzi: No. I prefer 1S. This is our deal, and I have a lot to describe, starting with a good prospective trump suit.

Foster: I disagree with the redouble. I would have bid 1S.

Praha: strongly disagree with Rdbl, I'd bid 1S

B. Cohen: No - I would have bid 1S and supported diamonds later.

Teukolskys: No! Redouble should show shortness in partner's suit and the ability to double two of the opponent's suits. Should bid 1S.

Schwartz: No. I would have preferred to get the information exchange started with 1S.

K. Cohen: NO. When you have a 6 card suit, it is better to just bid it. Remember it is standard to play new suit forcing.

Glassons: No. We would bid spades naturally over the takeout double.suit forcing at 1 level.

Raskin: Yes - Not enough to force to game and this might give us the most options as the auction progresses.

Filandro: Yes. Low-level penalty doubles are often lucrative. This hand qualifies because I was prepared to pass if partner had doubled a 1H run-out by West. If my hearts and clubs were reversed I would not have passed a double of a 1H run-out so I would have bid 1S in lieu of redouble to start getting my shape across.

Wachsman: Yes. The XX shows strength while allowing the most bidding space.

HARRIS: Agree. Too good for a 1S call.

I tend to agree with those who thought 1S would work better on most hands than XX.

Straguzzi: X. No alternative in my book, as this is the only way to show that I have spades after the redouble (and it's not like I have anything else to show, like four hearts or real diamond support or either rounded suit stopped.) 2S would show game-forcing values but deny a spade suit long and strong enough to propose playing for penalties; I doubt very much that king-queen-sixth qualifies. For what it's worth, I'm pretty sure West's spade bid is a psych, because it would leave partner with a spade void -- he'd probably have taken some action at his second turn. Now can I please take back that silly redouble?

Shuster: X. I don't expect this will end the auction, but I might as well expose LHO's psyche before bidding 4S, lest partner think I'm bidding exclusion or something.

Praha: X. When LHO (who has evidently psyched) runs, I can bid spades. If LHO's spade bid is natural, we have them by the throat.

Glassons: X. What else could we possibly do now? Partner's pass should suggest a willingness to defend, but our count says she is void

in spades, so maybe she is planning to pull the double. If she pulls to 2 diamonds, we will raise diamonds.

Raskin: X. Might miss a game but might also be heading for a great score.

K. Cohen: X. This is not what I expected to happen. This hand is very difficult to compute. For the time being, I am going to make a penalty DBL, because I expect partner to have some type of a weak shapely opener. Partner knows we are Vul and they are not. If he has a void, I would expect Partner to pull. If he has a stiff, I would expect him to pass and lead it. Dummy is likely to have Ax of Spades, and a strong enough hand to make a takeout dbl,(possibly 16+) 2425 pattern.

Filandro: X. I have no reason yet to expect a psyche.

Schwartz: X. Given I didn't like the XX on the first round, I must admit I can now X this for penalty which will describe what I have—that is, 10+ points and quite a few spades. I expect partner has a spade void and she might want to bid on, but at this point I think I'll tell her what I have and let her make the next guess—I should at least be well positioned for the *post mortem*. She can see the vulnerability as well as I can.

Teukolskys: X. Given the redouble, we now must follow through. Partner will presumably pull the double, but should have a reasonable hand because he didn't bid immediately.

Wachsman: 2NT. This bid clearly shows the spade stopper, 10-12 points, and permits North to better describe his hand.

B. Cohen: 2D. I am pleased with the turn of events - I now "know" my partner is void in spades and has at least 5 diamonds for his opening bid - we are in a good position to punish them if they get active at this point. **HARRIS**: X. Our only likely games are 3NT, 5D, or possibly 4H. EW should be really hurting at 1SX and I do not see an easy way for us to arrive at a good game unless partner pulls the double, showing a distributional two-suiter.

It was unanimous among the panel. First of all, what do we know about the hand? One thing we know that partner does not have a highly distributional hand. If she did, she would have bid in front of us. It would be useful to know whether advancer's pass of 1DXX would be penalty – many people play that after one of a minor. If so, advancer might have chosen to bid 1S on a three-card suit with 3-2-4-4 or 3-2-5-3 distribution. My belief is that someone will run if I double, either partner or advancer or doubler. So the best result available to me might well be defending 1S. Undoubled. Which is why I gave a score to a call not selected by anyone. The 1S contract would go down three, 150 for us, which was better than we could

get playing 3S, 2N, or defending 2CX. Partner was 1-4-4-4 and the doubler 3-4-1-5.

Shuster: 4D. Partner doesn't merely have independent hearts or he would have bid 3H over 2D. Partner's hearts are longer than his clubs or he would have bid 3C over 2S. Partner is also sufficiently unbalanced that he doesn't wish to pass 3NT. Despite these constraints, partner is still wide ranging. He could hold AQx, AKxxxx, ---, AQJx OR --, AKxxxxx, x, AQJxx and a lot of hands in between. What IS clear is that if partner has a diamond fragment, we will be much happier than if he has a spade fragment, so I'll let partner know where my most useful outside card is.

Foster: 5C. I judge my hand to be of minimal help to my partner, who seems to hold a two suiter in hearts and clubs. I prefer clubs.

Praha: 4H. Tough problem - if partner has a two suited hand with hearts and clubs, with his 2C opener based primarily on distribution, then 4H is right. If partner has 6-4 (or even the occasional 5-4) in hearts and clubs, 4NT rates to play better.

Raskin: 4S. Why didn't I bid 3S over 3H? This is a fairly decent hand and the S suit is certainly biddable.

Teukolskys: 4D. The CK is worth about 20 points, so we have to make a cue bid. Partner will probably trot out Blackwood next. He's most likely 7-4 (maybe 6-4) since he didn't bid 3C over 2S.

Filandro: 5C. With pleasure. I would never want to be lower with 3

second-round controls - yet I can't encourage higher with two fast spade losers. If partner has solid hearts and was making an advance cue bid, I am happy to make a return cue bid. If he has clubs, he will have at least 5, since I do not believe in introducing a 4-card suit at the 4-level.

Schwartz: 6C. Partner has a big two suiter, so don't think I can settle for less than 6C. Not sure how to investigate for 7C (4N might be construed as natural), maybe partner will be clairvoyant if the grand is on.

K. Cohen: 6C This is a very difficult hand. What does Partner have? Perhaps A, AKQxxx, x, AQJxx. If he has this, or something similar, the only slam that is favorite to make is 6C. It is always a good thing to visualize what Partner is likely to have before making a difficult decision. It is very difficult to almost impossible to construct a hand that you are off the first 2 tricks. Maybe if you think it out a little, this difficult hand becomes a lot easier to figure out.

Wachsman: 4H. Assuming partner has very good hearts, I will settle in the most likely successful game contract.

B. Cohen: 5C - (assuming no prior agreements that would make 4C anything other than a second suit) my clubs are obviously much better than my hearts and I wouldn't want 4D to be taken as showing the A the J of spades is surely worthless and the K of diamonds may have little value so 5C it is.

Glassons: 4D. Since partner's previous 3H bid showed a one-suited hand, 4C should be a cuebid confirming hearts as trump. We will cooperate by cuebidding our diamond control and over partner's 4H bid we will pass and over partner's 4S bid we will bid 5C. Our King of clubs must be a good value.

Straguzzi: 4D. Let's see...in Kokish, partner could have bid 3C at his third turn to show hearts and clubs. So, 4C cannot show a true two-suiter. Perhaps he has (say) seven strong hearts and four clubs, or perhaps, as I prefer, he has a self-sufficient heart suit and is cuebidding. If he meant 4C as Gerber, ahem, he and I will need to have a little chat after the session. Fortunately, no matter what he meant it as, 4D is the correct call -- a diamond control, a Last Train cue-bid showing useful values, or (*shudder*) no aces. I wish all of my partners' mystery bids were this easy.

HARRIS: 4D which should show interest in a slam. Partner has shown a 2 suited hand and this indicates club interest because I did not make a forward bidafter 3H. There is no reason to show a long

suit at the 4 level with a probable misfit in D.


Read Mike Shuster's comment. He covers most of what I want to say. I would expect partner to be at least two cards longer in hearts than in clubs, and would not be surprised to find her clubs not to be a real suit. In fact partner had a great hand: A/AKQ9xx/Ax/AJxx, and 6H is an excellent contract. You won't get there if you bid 4H, but if you bid 6C you will certainly play in that seriously inferior contract.

Nick Straguzzi and the Glassons scored 100. Well done. I would have scored 85. Best among the solvers were Raghu Rajkumar at 91 and Lynn Harris at 89.

A Spot 4 the Advancing Player

This is a continuing series of articles written for the advancing player. I welcome any questions or suggestions about future articles. Please send them to the publisher. Who knows? You may be mentioned in a future article! Since beginning this series, I have been asked about several conventions. Keep asking! Your questions give me direction about what the next article should be about.

This article is about how to bid the "Impossible Hand." Let us begin by explaining that there is no system of bidding to account for every possible opening bid. There will always be some hand that is impossible to bid. The Flannery convention was an early effort. Playing five-card major suit opening bids and a forcing 1NT response, the opening bidder was frequently strapped for a rebid after a 1NT response. Opening 2D showed an opening hand with four spades and five hearts, and solved that particular problem. However, it meant there was now no good way to open a weak two-bid in diamonds.

You are playing a modern variation of a five-card major suit opening system with 2C being the strong opening bid and pick up: AA VA 10 5 2 A K 8 3 A K 10 9. As dealer, vulnerable against not vulnerable, what do you open? Let us consider the choices. We can open either minor suit at the one level, One Heart, Two Clubs, or 2NT. None of these choices will allow us to accurately describe this hand. Any one-level opening bid risks everyone passing. We could easily make a game opposite a very weak hand that happened to have the right distribution. Suppose partner has five diamonds including the Queen and no other honors. 3NT should make 90% of the time, and we will be left at the one-level. Opening One Heart runs the additional risk of playing in a seven-card fit where a minor suit contract is superior. Opening Two Clubs merely postpones the problem. Opening 2NT certainly denies a singleton, and we have the risk of partner insisting on playing in spades with a weak six-card suit. We could easily make 3NT and go down in a Four Spade contract.

So, how do we solve these problems when the "impossible

hand" comes up? First, do not blindly make a choice. It is time to think about the possibilities - what can go right on a given choice and what can go wrong. Let us use this hand as an example of this thought process.

If we open at the one-level the auction is likely to end with three passes. If partner manages to bid anything, we might do all right. Over a response of One Heart, we can force to game; but that might not be enough. Over a response of One Spade, we can bid 3NT, but that risks missing a fit in hearts or either minor suit.

Opening Two Clubs is even worse because we will be at the two-level or higher and in no better position to judge what to do. Over a Two Diamond response, we can bid Two Hearts (showing a five-card suit) or 2NT (23-24 hcp). The only positive of opening Two Clubs is that partner will know we have a very strong hand. This guarantees that partner will not pass, but there is no certainty that partner will have a strong enough hand for whatever will be our final contract.

Opening 2NT also shows a very strong hand. It does not suffer from many of the negatives of opening Two Clubs. We will be able to get to a reasonable contract on virtually any hand where partner does not have either a reasonable hand with a poor six-card spade suit or a very poor hand with a five -card spade suit. We will have to accept a four-level transfer, but we could bid 3NT after a three-level transfer. Partner should get the idea that we do not want to play in that suit. Other auctions will proceed normally. We get to a heart game when that is right or to any minor suit contract. We can also find 3NT when that is a reasonable contract.

Do you think you will never have a hand that is impossible to bid? They happen all the time! Partner opens One Diamond and you hold: ♠4 ♥Q J 6 ♦10 8 2 ♣K J 7 4 3 2. There is no good bid here. 1NT with a singleton spade? Two Clubs with only seven hcp? Raising diamonds with only three-card support? The best choice here is One Heart on your three-card suit. The only really bad thing that could happen is a raise by partner with only three-card support. That does not happen very often.

How about ♠A J 7 3 2 ♥5 ♦K J 10 6 4 3 2 ♣void? This is an opening bid, but is One Diamond or One Spade the better choice? Will the form of scoring or the vulnerability matter to December 2011

you? It should. At favorable, I am much more likely to open One Diamond. Regardless how many hearts my opponents might bid, I can show my spade suit. At unfavorable, it is nowhere near as safe to bid diamonds first. If the opponents get to Four Hearts before my next bid, I will have a big problem because at that vulnerability it might not be safe to keep bidding.

There are many hands that are impossible to bid. The next time you see one (and you will!), take your time and figure out how to plan your bids to minimize the chance of getting yourself into a bad contract. Remember that your partner will imagine what you have based on what your bids mean, and not what you intend them to mean.


